

DEED OF VARIATION TO THE FUNDING AGREEMENT

BETWEEN

- 1) The Secretary of State for Education (the "Secretary of State"); and
- 2) Abingdon Learning Trust (the "Company") a charitable company incorporated in England and Wales with registered company number 07931886 whose registered address is at Hendred Way, Abingdon, Oxford, Oxfordshire, United Kingdom, OX 14 2AW, together, the "Parties".

INTRODUCTION

A. The Parties entered into a funding agreement dated on or about 26 November 2024 (the "Funding Agreement") relating to the establishment, maintenance and funding of an Academy, St Michael's CofE Primary School, in accordance with the Funding Agreement.

B. The Parties now wish to vary and amend certain terms and conditions of the Funding Agreement in accordance with the terms of this Deed.

c, This Deed is supplemental to the Funding Agreement.

1. INTERPRETATION

1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Funding Agreement.

2. VARIATION OF THE FUNDING AGREEMENT

2.1 The Parties agree that with effect from the date of this Deed the Funding Agreement shall be amended on page 4 as follows:

2.3 Except as varied by this Deed, the Funding Agreement shall remain in full force and effect.

its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.




